



AMATEUR LEAGUE PLAYER AGREEMENT

This Player Agreement (“Agreement”) is made on the ____ of **January, 2026** between:

- The Player confirms that they are registered and participate strictly as an **amateur player**.
- This Agreement does not create an employment, worker, or independent contractor relationship.
- The Player is not entitled to salary, wages, bonuses, or employment-related benefits.

Term

This Agreement shall commence on ____ **January 2026** and shall continue until **31 December 2026, unless terminated earlier in accordance with Clause 9 (Discipline & Termination)** of this Agreement.

Club Fees

- Annual Club Fees are **BBD \$300**, payable monthly at **BBD \$25**, unless otherwise agreed in writing.
- Where the Club permits participation without full payment during the season, the Player agrees that **any outstanding balance must be settled prior to being transfer** to another club; or Issuance of clearance or release documentation.

Club fees are a subsidy toward operational expenses including:

- Laundry of kits and training bibs
- Facility lighting
- Match-day refreshments
- Referee fees
- League registration and football equipment

Remuneration

- The Player acknowledges that the Club does not provide employment.
- No salary, wages, or guaranteed benefits shall be paid.
- Any travel or meal assistance is discretionary and does not create entitlement.

Player Obligations

The Player agrees to:

- Attend training sessions and matches when reasonably available
- Comply with Club rules, League regulations, and codes of conduct
- Act respectfully toward teammates, officials, opponents, and staff
- Maintain appropriate fitness, discipline, and behaviour
- Refrain from fighting, abusive language, or misconduct
- Keep your jersey on when substituted and seated on the bench
- Notify the Head Coach, Team Manager, or Medic of injuries or medical conditions
- Avoid conduct, including on social media, that may bring the Club or League into disrepute

Club Obligations

The Club agrees to:

- Provide access to training sessions, coaching, and matches
- Register the Player with the League where applicable
- Take reasonable steps to provide a safe training and playing environment

Medical, Risk & Insurance

- The Player confirms they are medically fit to participate.
- Participation is entirely at the Player's own risk.
- Mandatory insurance through the Barbados Football Association is the responsibility of the Player unless otherwise agreed in writing.
- The Player is responsible for their own medical expenses.
- Where the Club advances insurance or medical costs, the Player agrees to reimburse the Club upon receipt of any insurance payout.



Liability & Indemnity

- To the fullest extent permitted by law, the Club shall not be liable for injury, loss, or damage suffered during participation.
- The Player agrees to indemnify the Club against loss, damage, or liability arising from the Player's misconduct or breach of this Agreement.

Discipline & Termination

This Agreement may be **terminated prior to its expiry date** under the following circumstances:

Termination by the Club

The Club may suspend or terminate this Agreement if the Player:

- Breaches Club or League rules
- Engages in misconduct or unsportsmanlike behaviour
- Repeatedly fails to attend training or matches without reasonable excuse
- Brings the Club or League into disrepute

Where practicable, the Player shall be given an opportunity to respond before termination.

Termination by the Player

The Player may withdraw from the Club at any time by providing written notice to the Club. In such circumstances, the Player shall not be entitled to any compensation, refund of fees paid, reimbursement of expenses, or damages of any kind arising from such withdrawal.

Waiver of Claims upon Voluntary Withdrawal

Upon voluntary withdrawal under Clause 9.2, the Player releases and waives any present or future claim against the Club arising from participation or termination of this Agreement, except where prohibited by law.

League or Association Action

This Agreement may automatically terminate if the Player is suspended, deregistered, or banned by the League or Barbados Football Association for a period preventing participation.

Mutual Termination

This Agreement may be terminated at any time by mutual written agreement between the Player and the Club.



Image & Media Rights

The Player grants the Club, Barbados Football Association, CONCACAF and FIFA the right to photograph, record, film, and otherwise capture the Player's image, likeness, name, voice, and playing performance during training sessions, matches, and Club-related activities.

Such images and recordings may be used, reproduced, displayed, distributed, and published **during and after the term of this Agreement** for purposes including, but not limited to:

- Publication on the Club's website, social media platforms, and official communications;
- Promotion, advertising, and sponsorship activities of the Club or its partners;
- Marketing and promotional materials related to competitions or events;
- Player identification, scouting, trials, and **transfer-related purposes**.

Code of Conduct

The Player agrees to comply with:

- League regulations
- Anti-discrimination and anti-harassment policies
- Anti-doping rules (where applicable)
- Prohibitions on match manipulation or betting

Governing Law

This Agreement shall be governed by and interpreted in accordance with the **laws of Barbados**.



Entire Agreement

This Agreement constitutes the entire understanding between the parties.
